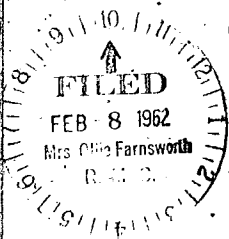

BEGINNING at an iron pin on the South side of Pellam Road at the Northwest corner of the McIntyre property and running thence with the line of the McIntyre property S 25°-28' E 100 feet to an iron pin; thence S 81° 40' W 60 feet to an iron pin; thence N 25° 28' W 100 feet to an iron pin on Pellam Road; thence along Pellam Road N 81° 40' E 60 feet to the point of the Beginning, being the Northeast corner of the tract of land conveyed to James L. Knight and Argle R. Knight by deed of Forest B. Ponder, dated September 1st, 1961 and recorded in Deed Book 682, at page 367 in the R.M.C. Office for Greenville County, and described in Plat Book WW at page 161 in the R.M.C. Office for Greenville County.

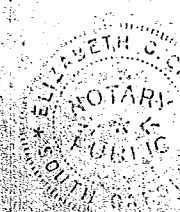
