To All Whom These Presents May Concern:

We, Charles R, McCurley and Peggy B, McCurley, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ABSOCIATION OF GREENVILLE, in the full and just sum of Eleven Thousand, Eight Hundred & no.100 — (\$ 11.800.00)

Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the fate specified therein in installments of second every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable — 25.— years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any, of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under sold note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee bedde-all costs and expenses of collection, to be added to the amount due under and autorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the southeastern side of Woody's Drive at the joint front corner of Lots 25 and 26, and running thence along the joint line of said lots, 3.38-30 E. 230 feet to a point in the center of Old Farr's Bridge Road; thence along the center of said Old Farr's Bridge Road, S. 82-30 W. 100 feet to an iron pin at the intersection of Hope Street; thence along the northeastern side of said Hope Street, N. 38-30 W. 200 feet, more or less; to a point at the intersection of said Hope Street and Woody's Drive; thence along the southeastern side of said Woody's Drive, N. 51-50 E. 100 feet to the point of beginning; being the same conveyed to us by Lloyd W. Gilstrap by deed of even date, to be recorded herewith."
