

NOW, KNOW ALL MEN, That I the said **Caroline L. Webster**

in consideration of the said debt and sum of money

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the southwesterly side of East Prentiss Avenue, in the City of Greenville, S. C. and being designated as the greater portion of Lots 20 and 21 and a small portion of Lot 22, Block D, on plat of Cagle Park Company as recorded in the RMC Office for Greenville County, S. C. in Plat Book C, page 238 and having according to a more recent survey entitled "Property of Caroline L. Webster dated January 29, 1962 and prepared by Dalton & Neves, Engrs." and being recorded in the RMC Office for Greenville County, S. C. in Plat Book ZZ, page 171, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of E. Prentiss Avenue, said pin located 624.35 feet from the southeasterly intersection of E. Prentiss Avenue and Augusta Street and running thence S 27-35 W 70.55 feet to an iron pin; thence S 29-57 W 20.4 feet to an iron pin; thence S 60-03 E 0.05 feet to an iron pin; thence S 31-57 W 61.7 feet to an iron pin in the line of a 15 foot alley; thence with said alley N 53-03 W 118 feet to an iron pin; thence N 31-15 E 53.3 feet to an iron pin; thence N 5-19 W 5.5 feet to an iron pin; thence N 32-33 E 59.3 feet to an iron pin; thence N 32-33 E 26.3 feet to an iron pin on the southwesterly side of E. Prentiss Avenue; thence with the southwesterly side of E. Prentiss Avenue S 55-30 E 44 feet to an iron pin; thence continuing with said Avenue S 57-14 E 17 feet to an iron pin; thence continuing with said Avenue S 59-27 E 54.35 feet to an iron pin, the point of beginning.

TOGETHER with all and singular the Rights, Member, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises unto the said PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, its Successors and Assigns forever.

AND I do hereby bind myself and my

Heirs, Executors and Administrators, Successors or Assigns, to warrant and forever defend all and singular the said Premises unto the said PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, its Successors and Assigns, from and against me and my Heirs, Executors, Administrators, Successors and Assigns, and all other persons whomsoever, lawfully claiming, or to claim the same, or any part thereof.

AND the said mortgagor doth, as additional security, hereby assign, set over, and transfer to the said mortgagee, all of the rents, issues and profits of the said mortgaged premises, accruing or falling due from and after the service of a summons in any action of foreclosure to which said mortgagee may be parties, and the holder of this mortgage shall be entitled to the appointment of a receiver for such rents and profits as a matter of right, without consideration of the value of the mortgaged premises as security for the amount due the mortgagee, or the solvency of any person or persons liable for the payment of such amount.

AND IT IS AGREED, by and between the said parties, that the said Mortgagor, Heirs, Executors, Administrators, Successors or Assigns shall and will insure the house and buildings on said premises and keep the same insured from loss or damage by fire, the perils covered by the standard Extended Coverage Endorsement or other hazards, that may be from time to time required by the Mortgagee, and assign the Policy of Insurance to the said PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, its Successors or Assigns, and in case that I or they shall, at any time, neglect or fail so to do, then the said PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, its Successors or Assigns may cause the same to be insured in its own name, and reimburse itself for the premium and expenses of such insurance, together with interest on the amount so paid, at the rate of seven (7%) per cent. per annum, from the date of such payment, under this Mortgage.

AND IT IS FURTHER AGREED AND COVENANTED, by and between the said parties, that until the debt hereby secured be paid, the said Mortgagor, her Heirs, Executors, Administrators, Successors or Assigns, shall and will pay all taxes on the property hereby mortgaged, when due and payable, and in case I or they fail to do so, the said PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, its Successors or Assigns, may pay said taxes, together with any costs or penalties incurred thereon, or any part thereof, and reimburse itself for the same, together with interest on the amount so paid, at the rate of seven (7%) per cent. per annum, from the date of such payment, under this Mortgage.
