NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, with the improvements thereon, situate, lying and being in the Piedmont Manufacturing Company Village in or near the town of Piedmont; Greenville County, South Carolina and being more particularly described as Lot No. 126. Section 4, as shown on a plat entitled "Revised Portion, Section 4, Piedmont Mfg. Co., Greenville County, S. C." made by Dalton & Noves, February, 1950, and recorded in the R. M. C. Office for Greenville County in Plat Book X at page 127. According to said plat, the within described lot is also known as No. 64 U. S. Highway 20 and fronts thereon 100 feet.

This is the identical property heretofore conveyed to the grantor by deed by Winifred T. Long and Clara \$. Long on the 5th day of August, 1952, and recorded in the R. M. C. Office for Greenville County in Deed Book 460 and page 303, and being identical property conveyed to Winifred T. Long and Clara S. Long by J. P. Stevens & Co. Inc. by its deed dated August 1, 1950, and recorded in R. M. C. Office for Greenville County in Deed Book 416 at page 354. This conveyance is made subject to all conditions, restrictions and reservations contained in deed of J. P. Stevens, Inc. above referred to.

Together with all and singular rights, members, herditaments, and appurtanences to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or little therefo in any manner; it being the intention of the parties hereto that all such fixtures and equipment; other than the usual household furniture, be considered a part of the real astate.

TO HAVE AND TO HOLD, all and singular the sald premises unto the Mortgoger, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully select of the premises hereinebove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
