SEND GREETINGS:

Fifty-Five and No/100 - - - - - (\$ 55,00 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 11 - / years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole mount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of Oregon Street, near the City of Greenville, being shown as Lot No. 5, Block D, on Plat of Kanatenah, as revised, recorded in the R.M.C. Office for Greenville County in Plat Book "F", at page 131, and having, according to said plat, the following metes and bounds:

"BEGINNING at an iron pin on the Northern side of Oregon Street, at the joint front corner of Lots Nos. 4 and 5, and running thence along the Northern side of Oregon Street, North 63-35 East 60 feet to an iron pin on line of Lot No. 6; thence along the line of Lot No. 6, North 26-30 West 165 feet to an iron pin, rear corner of Lot No. 13; thence with the rear line of Lot No. 13, South 63-35 West 60 feet to an iron pin, corner of Lot No. 4; thence with the line of Lot No. 4, South 26-30 East 165 feet to the point of beginning; being the same property conveyed to us by Forrest Webb Kiser by his deed dated February 8, 1962 to be recorded herewith."
