WILLIAM L. McCAFFERTY AND
JOCELYN ANN McCAFFERTY (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Seventy-Seven Hundred and No/100**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being known and designated as lot # 18 on plat of property of Elizabeth

E. Voyles, said plat being recorded in Plat Book Y at Page 73, in the RMC office for Greenville County and described as follows:

BEGINNING at an iron pin on the south side of Echols Drive, joint front corner of lots 17 and 18, and running thence with the line of lot 17, S. 21-42 E. 111.4 feet to iron pin; thence S. 68-18 W. 90 feet to an iron pin, joint rear corner of lots 18 and 19; thence with line of lot 19, N. 21-42 W. 111.4 feet to an iron pin on the south side of Echols Drive; thence with said Drive, N. 68-18 E. 90 feet to the point of beginning.
