TO ALL WHOM THESE PRESENTS MAY CONCERN:

**GEORGE PETERSON**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of One Thousand and no/100

DOLLARS (\$ 1,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, known as Lot 10 on plat of Property of Montevideo, Sect. 2, recorded in plat book MM at page 125, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Echo Lane at the corner of Lot 9, and running thence N 68-39 W, 164.7 feet to an iron pin; thence S 20-30 W, 100 feet to an iron pin; thence S 68-42 E, 163.9 feet to an iron pin on said Lane; thence N 21-08 E, 100 feet to the point of beginning and being a portion of that property conveyed to T. Hubert Stokes, et al, in deed book 587 at page 217, and the same to me by deed of T. Hubert Stokes, et al, recorded in the R. M. C. Office for Greenville County.

There is a mortgage executed by George Peterson to Travelers Rest Federal Savings & Loan Association in the sum of \$9,000.00, dated December 30, 1961, recorded in mortgage book 878 at page 182. These two mortgages shall be of equal rank. A default under either mortgage will constitute a default under both mortgages.
