NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All ~~that~~ <sup>those</sup> pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Colonial Avenue near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 12 and 13, Block V, as shown on a plat of Riverside recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book A at pages 322-323 and also on a duplicate plat of Riverside recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book K at pages 281-284, and having, in the aggregate, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Colonial Avenue at the joint front corner of Lots Nos. 13 and 14 of Block V, and running thence with the line of Lot No. 14 N. 10-15 E. 125 feet to an iron pin on the Southern side of a fifteen foot alley; thence with the Southern side of said fifteen foot alley N. 79-45 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12 and running thence with the line of Lot No. 11 S. 10-15 W. 125 feet to an iron pin on the Northern side of Colonial Avenue, thence with the Northern side of Colonial Avenue S. 79-45 E. 100 feet to the point of beginning.

Lot No. 13 is the identical property conveyed to R. C. Shelton and Irene Shelton by deed of Mary M. League, dated June 22, 1946, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 294 at page 149. R(oy) C. Shelton died testate on or about April 25, 1951, and devised the premises hereinabove described to the mortgagor herein (See Apartment 600, File 20, Office of the Probate Judge for Greenville County, South Carolina).
