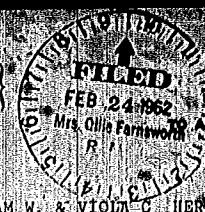

MORTGAGE OF REAL ESTATE

WHEREAS, WE, WILLIAM W. & VIOLET C. HERMAN

(hereinafter referred to as Mortgagor) is well and truly indebted unto DELTA CONSTRUCTION COMPANY, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagee's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of THREE THOUSAND ONE HUNDRED AND TWENTY-NINE and 00/100 Dollars (\$3129.00)

at the rate of 5 1/2% per month for 60 consecutive months, commencing on the 7th day of April, 1962, and the 7th day of each month thereafter until the entire balance is paid in full

with interest thereon from date of maturity of xxxxxxxx until such time as the entire balance is due and payable from that date a 7% per annum. WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Purchased in consideration of \$7600.00, containing an iron pin on the Eastern side of 4500 Foot sidewalk running along the Tindal Road, said pin being to a joint front corner of lots #83 and 84, thence along the Eastern edge of said sidewalk, N-42-32, E., 75 ft. to an iron pin, S-11-31 E., 102.56 feet to an iron pin, joint rear corner of lots #82 and 83, thence along the rear line of lot #80, S-11-54 W., 75 ft. to an iron pin, joint rear corner of lots #83 and 84, thence along the Northern line of lot #34, N., 84-34 W. 103 ft. to an iron pin, the beginning corner, being the same lot of land conveyed to me by Mauley Lumber Co by deed dated February 20, 1951 and for Greenville County in Vol. 429, page 390.
