This bond is one of an issue of 50 bonds duly authorized by the Corporation in the aggregate principal sum  
 of \$12,000.00 all being of like date, tenure and similar in every respect except the variations  
 necessary to express the denomination, the number and the maturity date.

The Corporation reserves the right to call this bond in for payment prior to maturity at any interest paying period, upon such notice as is provided for in  
 the resolution authorizing the issuance of this bond; and should this bond not be presented for redemption when matured or called for redemption, the same  
 shall cease to bear interest from and after such date.

Failure to pay any interest coupon on this bond when due shall, at the option of the holder, mature the principal thereof. In case this bond is placed in  
 the hands of an attorney for collection or suit is filed thereon, then the maker hereof agrees and promises to pay reasonable attorney's fees by reason thereof.

The maker hereof reserves the right to issue other bonds under the terms of the resolution hereinabove referred to.

This bond is an obligation of the Corporation only, and no recourse shall be had for the payment thereof against any officer, director or member of the  
 Corporation.

Certification is hereby made that all requirements, conditions and acts called for or to be performed under and by virtue of the resolution authorizing the  
 issuance of this bond have been complied with and properly executed in legal and due form, and that out of the revenue and income of the Corporation, a sum  
 sufficient to pay the interest and retire all of the bonds of this issue at maturity has been assigned, and will be deposited in a separate account in said bank  
 each week, and that such sum will be used for no other purpose.
