NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the west side of Woodland Drive in the City of Greer, being designated as Lot No. 15 of a subdivision known as PINEBROOK according to survey and plat by H.S. Brockman, Registered Surveyor, dated February 21, 1955, recorded in Plat Book FF, page 290, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a stake on the west side of Woodland Drive, corner of Lots Nos. 14 and 15, and running thence along the line of the same, S. 82-00 W. 203 feet to a stake on the brook; thence up said brook as a line, S. 23-48 E. 103.4 feet to a stake, corner of Lot No. 16; thence along the line of Lot No. 16, N. 79-30 E. 175 feet to a stake on the west side of Woodland Drive; thence along the west side of said Drive, N. 8-00 W. 92 feet to the beginning corner.

This is the same property conveyed to Marion C. Ponder, Jr. and Harriette M. Ponder by Roy E. Collins, Sr., et al., by deed recorded in Deed Book 521, page 269, R.M.C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
