BEGINNING on an iron pin on the south side of Snow Street, joint corner of this lot with Lot No. 5, and runs thence with the line of Lot No. 9, S. 7-55 W. two hundred eighty-two (282) feet to iron pin on line of Lot No. 12; thence with the line of Lot No. 12, S. 83-15 E. fifty three and eight tenths (53.8) feet to iron pin, corner of Lot No. 11, thence N. 7-05 E. two hundred eighty-one (281) feet to iron pin on the south side of Snow Street; thence with Snow Street, southside, N. 82-05 W. fifty (50) feet to the beginning corner; together with all improvements thereon.
