NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, being known and designated as lots # 31 and 32, as shown on a map of Royal Heights, recorded in Plat Book "W", at Page 25, and being more particularly described in a survey by C. C. Jones, Engineer, as follows:

BEGINNING at an iron pin in the east side of Irene Circle, joint front corner of lots # 32 and 33, and running thence with the joint line of said lots, N. 79-16 E. 140.7 feet to an iron pin; thence N. 0-30 W. 270 feet to an iron pin, corner of lot 31; thence with line of said property, N. 0-30 W. 39.6 feet to an iron pin; thence S. 59-18 W. 280 feet to an iron pin, corner of lot 30; thence with line of said lot, S. 7-33 E. 147 feet to an iron pin, the north side of Irene Circle; thence with the curve of Irene Circle, the chord of which is N. 88-42 E. 50 feet to an iron pin; thence continuing with the curve of Irene Circle, the chord of which is S. 36-0 E. 60 feet to the point of begiming.
