(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Seventh Street in Section 4 of Judson Mill Village in Greenville Township being shown as Lot No. 54 on plat recorded in Plat Book K at Page 75-76 and having according to said plat the following metes and bounds;

BEGINNING at an iron pin at the Northeastern corner of the intersection of Seventh Street and Hawkins Avenue and running thence with the North side of Seventh Street, N. 88-10 E. 79 feet to an iron pin at the corner of Lot No. 53; thence with Lot No. 53 N. 1-42 W. 123.8 feet to iron pin; thence with rear line of Lot No. 70, S. 88-16 W. 89 feet to iron pin on East side of Hawkins Avenue; thence with Eastern side of Hawkins Avenue, S. 1-42 E. 114 feet to an iron pin; thence with the curve of the intersection S. 46-46 E. 14.2 feet to beginning .
