Sloan and his heirs and assigns:

All that certain parcel or tract of land containing 9 acres, more or less, situated near Milford Baptist Church, Oneal Township, Greenville County, State of South Carolina, and having courses and distances according to survey and plat of the property of Garold D. Sloan by H.S. Brockman, Registered Surveyor, dated March 2, 1954, as follows, towit:
