"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being composed of parts of Lots 14 and 16 as shown on a plat of the property of C.
