TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, its successors and assigns forever. And I. do hereby bind myself and my Heirs, Executors and Administrators to warrant and foreyer defend all and singular the said Premises unto the said WOODRUFF FEDERAL SAV-INGS AND LOAN ASSOCIATION, its successors and assigns, from and against me and my.
