NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgage at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All Mixt certain piece, parcel &r lot &f land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Western side of Mills Avenue, being known and designated as Lots 10 and 11 on a plat of Kirkwood Heights, recorded in Plat Book RR at page 45, and having according to said plat, the following metes and bounds when described together:

BEGINNING at an iron pin on the Northwestern side of Mills Avenue, at the joint front corner of Lots 9 and 10 and running thence with Lot 9, N. 49-18 W. 145.9 feet; thence N. 40-42 E. 150 feet to pin at rear of Lot 12; theme with the line of Lot 12, S. 49-18 E. 144.5 feet to a pin on Mills Avenue; thence with Mills Avenue, S. 40-11 W. 150 feet to the point of Beginning.
