

County and State aforesaid, Highland Township, about one half mile north-east from Blue Ridge store, lying on the east side of the road that leads from Blue Ridge store to or near Pleasant Hill Church, and being the same land conveyed to Millard B. Crain; thence with the said line S. 81-30 W. 222 feet to an iron pin in the center of the said road; thence with the center of the said road S. 12-45 E. 203 feet to an iron pin in the center of the road; thence a new line S. 65-00 E. 526 feet to an iron pin in the woods (there is an iron pin on the bank of the road also at 30 feet on this line); thence N. 81-45 E. 412 feet to the beginning corner, containing 4.58 acres, more or less.
