C. or at such other place as the holder of the note may designate in writing, in monthly installments of SIXTY ONE AND 66/100 Dollars (\$ 61.66), commencing on the first day of June, 1962, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 92.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, shown and designated as Lot No. 1 of Block "C", on plat of Hughes Heights recorded in the R.M.C. Office for Greenville County in Plat Book "GC", Pages 122 and 123, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Almema Street, joint front corner of Lots Nos. 1 and 2, running thence along said Almema Street, S. 37-33 W., 52.3 feet to an iron pin; thence around the curvature of a circle, the chord of which is S. 80-31 W., 34.1 feet to an iron pin on the Easterly side of Service Drive; thence N. 56-30 W., along Service Drive, 17 1/2 feet to an iron pin; thence N. 26-26 E., 60.9 feet to an iron pin; thence S. 60-13 E., 210.3 feet to the point of BEGINNING.
