WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast side of Blue Mist Drive, shown as Lot No. 33 on Plat of Lockwood Heights, Section 3 recorded in the R.M.C. Office for Greenville County in Plat Book XX at Page 11 and being further described as follows:

BEGINNING at an iron pin on the Northeastern side of Blue Mist Drive at the joint front corner of Lot Nos. 32 and 33 and running thence with the joint lines of said lots, N. 37-49 E. 188.7 feet to an iron pin at the corner of Lot No. 29; thence along the rear of Lot No. 29, S. 39-36 E. 89.5 feet to an iron pin at the corner of Lot No. 34; thence along line of Lot No. 34, S. 36-52 W. 165.6 feet to an iron pin on the Northeastern side of Blue Mist Drive; thence along Blue Mist Drive N. 51-13 W. 90 feet to point of beginning.

Being the same property conveyed to the Mortgagors by deed recorded in Deed Book 695 at Page 326.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
