WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of the State of South Carolina, a corporation called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference in the principal sum of Eight Thousand Two Hundred and $\frac{1}{2}$ Dollars (\$8,200.00), with interest from date at the rate of five and one-fourth per centum ($5\frac{1}{4}$ %) per annum until paid, said principal and interest being payable at the office of General Mortgage Co., in Greenville, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty-five and $\frac{27}{100}$ Dollars (\$55.27), commencing on the first day of May, 1962 and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 1982.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land with the buildings and improvements thereon situated on the Southeast side of Landwood Avenue (formerly Fairview Avenue) in the City of Greenville in Greenville County, S.C., being shown on lot 17, in the adjoining portion of lot No. 16 of Block K on Plat of Public Lots, made by R. E. Dalton, engineer, November 1921, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book 3, page 27, and having according to said plat and a recent survey made by R. K. Campbell, Surveyor, April 7, 1962, the following lines and bounds, to wit:

Beginning at an iron pin on the Southeast side of Landwood Avenue, front corner of lot No. 17 and 18 of Block K and runs thence along the line of lot No. 18 S. 138-40 E. 117 feet to an iron pin; thence S. 41-20 W. 63-33 feet to an iron pin in the rear line of lot No. 16; thence through lot No. 16 N. 68-40 W. 133 feet to an iron pin on the Southeast side of Landwood Avenue; thence along Landwood Avenue N. 31-17 E. 83-33 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
