BEGINNING on a point on the northwest edge of the said Rutherford Road, joint corner of the Earnest Mack lot, and runs thence with the Earnest Mack line, N. 64-45 W. 381 feet to an iron pin on the said line; thence a new line, S. 45-00 W. 107.7 feet to an iron pin, new corner; thence S. 60-15 E. 359 feet to a point in the northwest edge of the said Rutherford Road (atake back on line at 10 feet); thence with the said road, N. 50-15 E. 142 feet to the beginning corner.
