The last payment on said note, if not paid earlier and if not subsequently

"BEGINNING at an iron pin on the western side of Ridgeway Drive, the joint front corner of Lots 181 and 182, and running thence with the joint line of said lots, N. 69-42 W. 149 feet to an iron pin at the joint rear corner of said lots; thence with the rear line of Lot No. 182, N. 17-15 E. 50.05 feet to an iron pin, joint rear corner of Lots 182 and 183; thence with the joint line of said lots, S. 69-42 E. 146.1 feet to an iron pin on the western side of Ridgeway Drive, the joint front corner of said lots; thence with the western side of Ridgeway Drive, S. 14-32 W. 50.25 feet to the beginning corner; being the same conveyed to me by J. D. Vaughn, et al. by deed dated February 19, 1959 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 617, at page 285."
