"BEGINNING at an iron pin on the eastern side of Circle Street, now known as Converse Street, at the joint front corner of Lots Nos. 13 and 14, and running thence along the joint line of said lots, N. 70-24 E. 172.3 feet to an iron pin in the rear line of Lot No. 2; thence along the line of Lot No. 2, S. 27-42 E. 60 feet to an iron pin at the corner of Lot No. 3; thence along the rear line of Lot No. 3. S. 12-21 W. 20 feet to an iron pin at the joint rear corner of Lots 12 and 13; thence along the joint line of said lots, S. 74-31 W. 214.6 feet to an iron pin on the eastern side of Circle Street, now known as Converse Street, at the joint front corner of Lots 12 and 13; thence along the eastern side of said street, N. 16-25 E. 75 feet to the point of beginning; being the same conveyed to me by Lillie C. Pickel by deed of even date, to be recorded herewith."
