(hereinafter referred to as Mortgagor) SEND (\$) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Five Thousand Five Hundred and no/100-----

DOLLARS (\$ 5,500.00----), with interest thereon from date at the rate of Six (6%)---

per centum per annum, said principal and interest to be repaid in monthly instalments of

Forty Six and no/100--- Dollars (\$ 46.00) each on the first day of each month hereafter

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Western side of Hunt's Bridge Road, being the Southern portion of a 12 acre tract conveyed to the mortgagor by deed recorded in Vol. 695 at page 29, containing 2.8 acres, and having according to a recent survey made by J. C. Hill, dated April 22, 1962, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Hunt's Bridge Road, at the corner of the .94 of an acre tract shown on plat recorded in Vol. PP at page 47, and running thence with the Western side of Hunt's Bridge Road, N. 22-10 W. 295.3 feet to an iron pin; thence S. 63-15 W. 577 feet to a pin; thence S. 3 E. 103 feet to a pin; thence S. 62 E. 81.1 feet to a pin; thence N. 82 E. 94 feet to a pin on a branch; thence with the branch as the line the following courses and distances: N. 41-30 E. 70 feet; thence 59-30 E. 83 feet; thence N. 70-30 E. 154 feet; thence S. 73-30 E. 142 feet; thence N. 81-30 E. 20 feet, more or less, to a pin on the Western side of Hunt's Bridge Road, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
