Green, on the south by lands of E.H. Green and myself and on the west by lands of Ben Singleton, and being a part of the same land that was conveyed to me by deed from E.H. Green September 27th, 1948 recorded in the R.M.C. Office for creenville County in Deed Book 360 at page 439 and having the following courses and distances, to wit:

BEGINNING on a stake in the center of the said road at 33 feet from the joint corner of the Singleton lands and lands of myself and runs thence with the Ben Singleton line, S. 18-45 W. 391.2 feet to an iron pin on the said line (there is also an iron pin on the south bank of the said road at 40 feet); thence N. 48-31 E. 150.9 feet to a stake or iron pin, joint corner of the E.H. Green land and other lands of myself, then continuing with the same course 201.4 feet to an ironnpin (making a total distance for this line 352.3 feet): thence with another of the E.H. Green lines, N. 8-34 W. 223 feet to a stake on the center of the said new road (iron pin back on line at 28 feet); thence with the center of the said road, S. 50-51 W. 133.5 feet to the beginning corner, containing one and Eight one-hundredths (1.08) acres, more or less.
