NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

About four (h) miles northwest of Greenville Court house, near Berea School, on the estern side of the White Horse Road, and according to a survey and plat thereof made by Pickell & Pickell, Engrs., July 20, 1949, having the following metes and bounds, courses and distances, to-wit:

REGINNING at a point in western right of way line of the White Horse Road, joint corner with land of J. T. Burdine, Jr., at driveway, and running thence S. 4-00 E. 190 feet along the western right of way line of said White Horse Road, to point, joint corner with other lands of said J. T. Burdine, Jr; thence S. 81-51 W. 386.5 feet along line of Burdine property to point; thence N. 4-00 W. 100 feet along line of Burdine property to point; thence N. 81-51 E.386.5 feet along line of Burdine property to point of beginning on western side of said White Horse Road.

This was recorded by Mary B. Gooper by deed dated Sept. 10, 1943, recorded in Vol. 256, at page 264 in the R. M. C. office for Greenville County, the original tract containing 12 acres, more or less.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully selzed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the sell of premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
