All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Dunklin Township, containing approximately 14.78 acres, by computation, and being situate northeast of the intersection of Augusta Road and Cooley Bridge Road, and having the approximate courses and distances, to-wit:
