NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city of Greenville, being shown as lot No. 16 on plat of Section A, of Gower Estates made by Dalton & Neves, Engineers, January 1960, recorded in the RMC Office for Greenville County, S. C., in Plat Book QQ, pages 146 and 147, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Windfield Road at joint front corner of Lots 15 and 16, and runs thence with the line of lot 15, N. 74-48 E. 158 feet to an iron pin in the center of a branch; thence up the branch following the center line thereof (the traverse line being N. 16-0 W. 130.6 feet) to an iron pin in the center of branch; thence with the line of Lot 17, S. 74-32 W. 156.4 feet to an iron pin on the east side of Windfield Road; thence along Windfield Road S. 15-50 E. 100 feet to the beginning corner.
