in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Leslie & Shaw, Inc., its successors and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot No. 194 of a subdivision known as Orchard Acres, Section Three, as shown on a subdivision plat to be recorded, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Hartsville Street, the southwest corner of Lot No. 195 as shown on a plat recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at page 143, and running thence along the western line of that lot, N. 3-12 W. 160 feet to an iron pin at the northwestern corner of said lot; thence S. 75-40 W. 101.9 feet to an iron pin; thence S. 3-12 E. 140 feet to an iron pin on the northern edge of Hartsville Street; thence along the northern edge of Hartsville Street, N. 86-39 E. 100 feet to the beginning corner; being the same conveyed to me by Leslie & Shaw, Inc. by deed of even date, to be recorded herewith.
