All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oaklawn Township, on the southwestern side of a county road leading to Fork Shoals and being shown as a two-acre tract of land on the plat of Property of W. F. Davis, prepared by C. O. Riddle, dated Nov. 15, 1961 and having, according to said plat, the following metes and bounds, to-wit:
