NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, lying on the north side of Buncombe Street in the City of Greer, and being shown and designated as Lot No. 12 on plat of N.M. Cannon property as subdivided by H.S. Brockman, Surveyor, dated January 16, 1924, and having the following courses and distances, to-wit:

BEGINNING on a stake on the north side of Buncombe Street, the same being the joint corner of Lots Nos. 12 and 13, and runs thence with the northern side of Buncombe Street, N. 76-45 E. 50 feet to a stake, joint corner of Lots Nos. 11 and 12; thence with the line of Lot No. 11, N. 13-00 W. 204.5 feet to a stake; thence S. 77-00 W. 50 feet to a stake, joint corner of Lots Nos. 12 and 13; thence with the line of Lot No. 13, S. 13-00 E. 204.5 feet to the beginning corner.
