(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 20,000.00 ), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid in monthly instalments of -----

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, on the eastern side of East Faris Road, being known and designated as Lot No. 98 as shown on plat of Forest Heights, recorded in Plat Book P at Page 71, and being more particularly described according to said plat, as follows:

"BEGINNING at an iron pin on the eastern side of East Faris Road, at joint front corner of Lots Nos. 97 and 98, and running thence with the joint line of said lots, N. 77-53 E. 225 feet to a point in the center of a branch; thence up the meanders of said branch, the chord of which is N. 25-30 W. 201.6 feet to a point in the center of said branch, joint rear corner of Lots Nos. 97 and 99; thence with the joint line of said lots, S. 58-00 W. 235 feet to an iron pin in the eastern side of East Faris Road; thence with said Road, S. 31-00 E. 100 feet to an iron pin; thence still with said Road, S. 18-54 E. 25 feet to the point of beginning."
