"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern corner of Intersection of Dakota Road and Windfield Road, near the City of Greenville, being shown as Lot No. 19 on Plat of Section A, Gower Estates, prepared by Dalton & Neves, Engineers, January, 1960, recorded in the R. C. Office for Greenville County, South Carolina, in Plat Book QQ, Pages 146 and 147, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin at the Northeastern corner of Dakota Road and Windfield Road, and running thence with the Eastern side of Dakota Road, N. 31-42 E. 125 feet to an iron pin at the corner of Lot No. 20; thence with the line of said lot, S. 67-23 E. 253.1 feet to an iron pin at the corner of Lot No. 18; thence with the line of said lot, S. 31-42 W. 190 feet to an iron pin on said Road, N. 58-18 W. 225 feet to an iron pin at the corner of Dakota Road; thence with the line of said lot, S. 31-42 W. 190 feet to an iron pin at the corner of Dakota Road; thence with the curve of the Intersection, the chord of which is N. 13-18 W. 35.3 feet to the BEGINNING corner.
