That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the phymont thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truff paid by the Mortgagoe at and before the sealing and delivery of those presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, at the Southwestern corner of Waddell Road and Flamingo Drive, me ar the City of Greenville, and being shown as Lot No. 1 on Plat of Wade Hampton Gardens, recorded in Plat Book MM, Page 199, and described as follows:

BEGINNING at an iron pin at the Southwestern corner of Flamingo Drive and Waddell Road, and running thence with the Western side of Waddell Road, S. 9-38 W. 115.2 feet and S. 16-19 W. 135 feet to an iron pin; thence N. 47-07 W. 69 feet to an iron pin; thence N. 36-06 W. 155.5 feet to an iron pin at the corner of Lot No. 2; thence with the line of said lot, N. 38-36 E. 214.6 feet to an iron pin on Flamingo Drive; thence with the Southwestern side of said Drive, S. 44-13 E. 75 feet to an iron pin at the corner of Waddell Road; thence with the curve of the Intersection, the chord of which is S. 17-18 E. 44.5 feet to the BEGINNING corner.
