ALL that lot of land with the building and improvements thereon situate at the Southwest corner of the intersection of Bridgewater Drive and Arundel Road near the City of Greenville in Greenville County, South Carolina, being shown as lot #176 and a portion of lot #177 on plat of Sector IX of Botany Woods made by Piedmont Engineering Service, April 1961, recorded in the R. M. C. Office for Greenville County, South Carolina in plat book "YY" page 23 and having according to maid plat the following metes and bounds to-wit:
