FOR VALUE RECEIVED, I, Sarah H. Moore, do hereby release the following described property and improvements thereon, being a part of the property listed as collateral under a real estate mortgage owned and held by me dated March 22, 1962, of record in Mortgage Book 885, at page 290, in the R.M.C. Office for Greenville County, South Carolina, to the intent that the property so released may be discharged from said mortgage free and clear of all liens and claims thereunder and that the remainder of the property specified in said mortgage not heretofore released will remain mortgaged:

E. Heath, Jr. and Sue E. Heath, by J. H. Mauldin by deed dated August 4, 1961, of record in Deed Volume 679, at page 367, in the RMC Office for Greenville, South Carolina."
