ANTEL VARAS and, BETTY A. VARAS

(hereinafter referred to as Mortgagor) SEND (\$1) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagor), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-seven Thousand Five Hundred

DOLLARS \$ 27,500.00 with interest thereon from date at the rate of five and three-fourths per centum per annum, said principal and interest to be repaid in monthly installments of One Hundred Ninety-four Dollars (\$194.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal and .

NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand-will and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

All that certain piece parcel or lot of land, with all improvements thereon, so far as constructed thereon, situate being and lying in the State of South Carolina, County of Greenville, near the City of Greenville, on the North side of Roper Mountain Road, and containing 5.13 acres, according to survey made by C. O. Riddle, Surveyor, June, 1960, and having according to said survey the following metes and bounds, to wit:

BEGINNING at an iron pin in the center of Roper Mountain Road, said pin being 699.3 feet West from a point in the center of intersection of Roper Mountain Road and Mill Road, and running thence with the center of Roper Mountain Road, N. 76-27 W., 523.3 feet to an iron pin in the center of said Roper Mountain Road; thence along line of property of Jessica C. Mayes, N. 26-26 E., 493.3 feet to an iron pin; thence along line of property of Adams, S. 77-06 E., 403 feet to an iron pin; thence along line of other property of the said Jessica C. Mayes, S. 12-22 W., 485.3 feet to the beginning corner.
