NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its. successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the western side of Lake Forest Drive on plat of Stone Lake Heights, recorded in Plat Book W at page 87, and having according to a revised plat made by Piedmont Engineering Company the following metes and bounds:

BEGINNING at an iron pin on the Western side of Lake Forest Drive, joint front corner of Lots 46 and 47, and running thence with the line of Lot 46, N. 75-34 W. 279.7 feet to a pin; thence following the high water mark of Stone Lake, 129.3 feet to a pin at corner of Lot 48; thence with line of Lot 48, S. 78-48 E. 243.4 feet to a pin on Lake Forest Drive; thence along the Western side of Lake Forest Drive,, N. 12-21 E. 110 feet to the point of beginning.
