COUNTY OF GREENVILL To All Whom These Presents May Concern: I, Freeda M. Sanders, of Greenville County, SEND GREETINGS: WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-VILLE, in the full and just sum of Five Thousand, Five Hundred and No/100 - (\$ 5,500.00) Dollars' (or for tuture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of

ances, and then to the payment of principal. The last payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal.
