WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing of such sets with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENoriginal sum of

VILLE, in the maximocourses of Thirteen Thousand, Fifty and No/100 = - (\$13,050,00)
Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes set-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal hat ances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable — years after date. The note further provides that if at any time is continuous of the principal or interest due thereunder shall be past due and unpaid for a period of thir; (30) days in failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage. Whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney is fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appears.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the turther sum of Three Dollais to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

Office for Greenville County in Plat Book UU, at Page 5 and having, according to a survey and plat prepared by C. C. Jones, C. E., May 22, 1962, the following metes and bounds,

"BEGINNING at an iron pin on the eastern side of Sylvania Drive, the joint corner of Lots 10 and 11 as shown on the aforesaid subdivision plat recorded in Plat Book UU, at Page 5 and running thence along the joint line of said lots, N. 47-21 E. 61.3 feet to an iron pin, the joint corner of Lots 9, 10 and 11; thence along a new line through Lot 10, S. 55-15 W. 59.9 feet to an iron pin on the eastern side of Sylvania Drive; thence along the eastern side of Sylvania Drive, S. 28-29 E. 8 feet to the beginning corner; being the same property conveyed to us by Darrell M. Holland by his deed of even date to be recorded herewith."

The promissory note hereinabove referred to is secured by a mortgage executed by the mortgagors herein to the mortgagee herein on November 3, 1961 and recorded in the R.M.C. Office for Greenville County in Mortgage Book 873, at Page 446. It is understood and agreed that this mortgage is given as additional security for the same note, and does not constitute a new debt.
