NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee'at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, Greenville County, at the Western intersection of Highway 253 and a County road leading to the Tigerville-Travelers Rest Road and being shown on the County Block Book as Page 649.3, Block 1, Lot 1, and described as follows:

BEGINNING at a point in the center of the intersection of Highway 253. and said County Road leading to the Tigerville-Travelers Rest Road and running thence with the center of Highway 253 in a Northwesterly direction 917 feet, more or less, to a point; thence leaving said road, S. 61-05 W. 170 feet to a stake; thence S. 22-23 E. 353 feet to an iron pin; thence S. 6,35 E. 365 feet to a point in the center of said County Road leading to the Tigerville-Travelers Rest Road; thence with the center of said Road, S. 87-45 E. 250 feet to a point; thence leaving said Road, S. 15-30 E. approximately 120 feet to a point; thence in a Northeasterly direction 470.58 feet to the Beginning corner.
