TO ALL WHOM THESE PRESENTS MAY CONCERN: WILLIAM V. LANFORD and M. L.

LANFORD, JR. (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor, in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release, unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Fenwick Lane, in Paris Mountain Township, being shown and designated as Lot No. 25 of Section I of Fenwick Heights, recorded in Plat Book QQ, Page 44, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Fenwick Lane, joint front corner of Lots No. 25 and 24, and running thence with the line of Lot No. 24; S. 35-25 W. 200 feet to an iron pin; thence N. 54-40 W. 172.5 feet to an iron pin; thence N. 48-43 E. 185.4 feet to an iron pin on Fenwick Lane; thence with the Southwestern side of Fenwick Lane, S. 63-02 E. 131 feet to the point of BEGINNING.

Being one of the lots conveyed to the Mortgagors by Deed recorded in Deed Book 690, Page 14.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
