NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL, SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents, the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, targain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"BEGINNING at an iron pin on the Northwest side of Central Avenue, joint corner with Lot No. 48, and running thence N, 71-32 W. 115 feet to an iron pin; thence N. 15-00 E. 196 feet to an iron pin on an unnamed street; thence along said street, S. 75-00 E, 175 feet to intersection with Central Avenue; thence along Central Avenue, S. 31-37 W. 211,5 feet to the beginning corner; being the same conveyed to me by Levis L. Gilstrap by deed to be recorded herewith.

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums; a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged. property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagea) less all sums already paid therefor, divided by the number of months to clapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay salid premiums, taxes and special assessments.
