To All Whom These Presents May Concern

SEND GREETING

Whereas I, the said Alice O. Martin, in and by my certain note in writing of even date with these Presepts, am well and truly indebted to Palmetto Bank in the full and just sum of Nineteen thousand two hundred eighty eight and 50/100 (\$19,288.50) to be paid in five equal annual installments of \$4857.70 each plus accumulated interest with interest thereon from date at the rate of 5 per centum per annum, to be computed and paid annually until paid in full; all interest not paid when due to bear
