TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor), SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, CREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgager's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of TWENTY THOUSAND FIVE HUNDRED ----DOLLARS-(\$ 20,500.00 . ), with interest thereon from date at the rate of five & . 3/4 per centum per annum, said principal and interest to be repaid in-monthly instalments of One Hundred Twenty-nine --- Dollars (\$129.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt; and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgager in hand, well and truly paid by the Mortgagee at and before the scaling and delivery of those presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, soll and release into the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and design nated as Lot No. 5 of a subdivision known as Wellington Green as shown on plat thereof prepared by Piedmont Engineering Service, October 11, 1961, recorded in the RMC Office for Greenville County in Plat Book YY, at page 2 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pia on the western edge of a turn around on Melbourn Lane, the joint front corner of Lots 4 and 5, and running thence along the joint line of said lots, N. 72-20 W. 213.7 feet to an iron pin on the subdivision boundary line; thence along the subdivision boundary line, N. 9-16 E. 133.0 feet to an iron pin, the joint rear corner of Lots 5 and 6; thence along the joint line of said lots, S. 55-24 E. 193.3 feet to an iron pin on said turn-around; thence along the western edge of said turn-around, following the curvature thereof, the chords being 3. 1-10 E. 61.3 feet and S. 44-10 E. 35 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging of in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and may other equipment or fixtures now or horeafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures and equipment, other than the usual houselfold furniture, be considered a part of the real estates
