C., being shown as lot #57 and the Southern 12.5 feet of lot 58 on Plat of Lanneau Drive Highlands made by Dalton & Neves, Engineers, August 1937, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "D" at Pages 288 and 289, said lot fronting 62.5 feet along the West side of Lanneau Drive, running back to a depth of 150 feet on the South side, to a depth of 150 feet on the North side, and being 62.5 feet across the rear.
