"All that certain piece, parted or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, lying on the south side of the Gap Creek Road about 4 miles north of the City of Green, clutaining 4 acres, more or less, bounded on the north by said road, on the east by John Howard, on the south by the center of the Duke Power Company and lands reserved by the mortgagors, and on the west by Egbert Mosteller Estate, having the following courses and distances:
