All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, dituate, lying and being in the State of South Carolina, County Greenville, Highland Township, in the Village of Tigerville, being all of the same lands conveyed to Trusters of North Greenville Baptist Church by Pearl McKinney Holcombeknown as Gin Lot, and by W.D. Neves and Carl A. Neves, as Executors of the Estate of B.F. Neves, shown on Plat Book K, page 61, R.M.C. Office for Greenville County, having the following courses and distances, to-wat:
